

CONDITIONS

1. The Account Holder must have or open a regular shares account in order to open the JPS&PCU Partner Plan account. All proceeds from the Partner Plan account will be credited to your account on maturity.
2. Payments must be made on the agreed dates each week, fortnight or month. These dates are determined by the payment schedule - weekly, fortnightly, or monthly installments - chosen at the time of opening as follows:
 - Weekly Plan payments are due on the same day each week
 - Fortnightly Plan payments are due on the same day each fortnight
 - Monthly payments are due on the same day each month
3. Where the payment date falls on a public holiday or weekend, payment is due the business day following the due date.
4. Bonus payments will be made at maturity of the Plan.
5. The Account holder will forfeit all rights to any bonus payments if the funds from this account are withdrawn prematurely, or if any of the stipulated conditions of the plan are breached. Premature withdrawal constitutes any withdrawal before the plan matures.
6. Bonus is paid based on the chosen Plan (i.e. the number of weeks the account is maintained) and is directly related to the amount saved in each designated "han" (weekly amount) with amount paid.
